APPLICATION TO COURT IN RELATION TO THE FILING OF ORIGINATING CLAIM AGAINST KLEIO ONE-SOLUTION PTE. LTD. ("DEFENDANT") IN HC/OC 788/2023 ("OC 788")

We refer to the announcements dated 17 November 2023, 19 December 2023, 28 December 2023, 29 February 2024, 5 April 2024, 19 April 2024, 21 May 2024 and 6 June 2024 (the "**Previous Announcements**") in respect of the claim by HSBC Institutional Trust Services (Singapore) Limited, as trustee for Sabana Industrial REIT ("**Claimant**") against the Defendant in OC 788.

Further to the Previous Announcements, Sabana Real Estate Investment Management Pte. Ltd., as manager of Sabana Industrial Real Estate Investment Trust ("Sabana Industrial REIT", and manager of Sabana Industrial REIT, the "Manager") wishes to update unitholders of Sabana Industrial REIT ("Unitholders") that, on 27 August 2024, the Appellate Division of the High Court ("ADHC") has <u>dismissed</u> the Defendant's appeal against the orders made by the General Division of the High Court ("GDHC") on 21 May 2024. The ADHC therefore upheld the following orders made by the GDHC on 21 May 2024 ("Order of Court"):

- (a) Summary judgment be granted against the Defendant on the Claimant's claims for outstanding rent and other payments due under the lease; and
- (b) The amendments proposed by the Defendant to its Defence and Counterclaim be disallowed.

The ADHC also ordered the Defendant to pay to the Claimant costs occasioned by the appeal, and affirmed the orders for the Defendant to pay costs to the Claimant made by the GDHC on 5 April 2024 and 21 May 2024.

There are no further avenues for the Defendant to appeal the ADHC's decision.

The Manager will, in compliance with the Listing Rules of Singapore Exchange Securities Trading Limited, make the relevant announcements on SGXNet as and when there are material developments in this matter.
